Eligibility Criteria for Board of Directors Candidates:

Applicants **must meet the following requirements** in line with the Sacco By-laws:

Active Sacco Membership: Must have been a member for at least **one (1) year** prior to the AGM.

Financial Standing: Must have:

- **Minimum Share Capital** of Kshs.100,000
- **Minimum Deposits** of Kshs.1,000,000

Loan Repayment History: Must not have been **delinquent** on any Sacco loan for more than **60 days** in the last two years.

Governance & Ethics: Must not have:

- Been adversely mentioned in any official **inquiry or inspection report** for mismanagement or corruption.
- Been barred by **SASRA** or any **government agency** from holding a leadership position.
- Been convicted of **fraud, dishonesty, or financial misconduct**.

Qualifications & Skills:

- Must have a **minimum O-level education** or equivalent.
 - Must demonstrate **leadership skills**, knowledge of the **Sacco movement**, and the ability to work in a team.

Eligibility Criteria for VNEC Candidates:

In addition to the above, VNEC candidates must demonstrate:

- Ability to **review, interpret, and enforce** Sacco By-laws, SASRA regulations, and election policies.
 - Neutrality & Independence** – Must remain impartial during the vetting and election process.
